

The email should be sent from the candidate's email ID mentioned in Sl. No. 14 of the application form. The subject line of the email and the attached excel file name should be "**Candidate's Name-Stenographer-III Post**".

Step 4:-

Submit the hard copy of the application form either by post or in person to the **Registrar General, High Court of Manipur, Imphal, Mantripukhri-795002**, duly signed by the applicant on or before **22nd May, 2015** along with Banker's Cheque/Demand Draft to be drawn from **any branch of SBI (Payable at Imphal)** for Rs. 700/- (Rupees Seven Hundred) only [Rs. 500/- (Rupees Five Hundred) only in case of candidates belonging to SC/ST] in favour of **Registrar General, High Court of Manipur**.
