

**Stenographer Grade – I**

- a) The candidate must be a Graduate from a recognized University.
- b) The candidate must have completed Diploma in Stenography in English with Minimum speed of 120 words per minute in short hand and typing speed of 50 words per minute on computer.

**Stenographer Grade – II**

- a) The candidate must be a Graduate from a recognized University.
- b) The candidate must have completed Diploma in Stenography in English with Minimum speed of 100 words per minute in short hand and typing speed of 40 words per minute on computer.

#### 4. Nature of Examination:

##### (i) Preliminary Examination:

(a) **Written examination** to test English for 50 marks with 1:30 hours duration consisting of Multiple Choice Questions (MCQs).

(b) **Computer Typing Test:** Minimum Speed of **50 wpm** on computer for the post of Stenographer Grade-I and **40 wpm** for the post of Stenographer Grade-II.

(c) **Stenography Test:** Minimum **60 wpm in short hand** for Stenographer Grade – I/PS  
Minimum **50 wpm in short hand** for Stenographer Grade - II

##### (ii) Mains:

Candidates selected from the Preliminary Examination will undergo Stenography Skill Tests for 75 marks.

##### (iii) Oral Interview:

Oral Interview for 25 Marks will be conducted for the candidates who got through the Main Examination.

**9. Mode of Payment:**

To be deposited only in the form of challan (**annexed as Annexure 'A' for Stenographer Grade-I and as Annexure 'B' for Stenographer Grade-II alongwith the Application form**) with SBI Branches through core banking network all over India on or before **23<sup>th</sup> May, 2017**. Original copy of challan must be attached alongwith the application form.

10. Applicants in Govt. service other than casual or muster roll will be required to state in the application form that they have informed in writing their employer/controlling authority that they are applying for the examination. In case the employer or the controlling authority withholds permission to the candidate for appearing in the examination, such applications will be rejected.

11. The **Admit Card** will be available in the High Court of Manipur website and the date for downloading the same will be notified later.

12. The decision of the High Court of Manipur as to the eligibility or otherwise of a candidate for admission to the Examination shall be final. If on verification at any time before or after the Written Examination and Interview, it is found that a candidate does not fulfill any of the eligibility conditions, his/her candidature for the Examination will be cancelled by the High Court of Manipur.

**13. Mobile Phones Banned:**

(a) All types of electronic gadgets including mobile phones, pagers etc. are not allowed inside the premises where the examination is being conducted. Any infringement of these instructions shall entail disciplinary action including ban from future examinations.


