

Submit the filled in Application Form either by post or in person to the **Registrar General, High Court of Manipur, Imphal, Mantripukhri-795002**, duly signed by the applicant on or before **24<sup>th</sup> February, 2015** along with Banker's Cheque/Demand Draft to be drawn from **any branch of SBI (Payable at Imphal)** for Rs. 500/- (Rupees Five Hundred only) [ Rs. 300/- (Rupees Three Hundred only) in case of candidates belonging to SC/ST] in favour of **Registrar General, High Court of Manipur.**
