
No. HCM/R-3/2018-Estt.-II/ 16209 : In continuation to this Registry's Advertisement of even number dated 19<sup>th</sup> April, 2023 and subsequent notification of even number dated 12<sup>th</sup> June, 2024 regarding recruitment for **Group – D posts** in the District Courts of Manipur, and as per the decision taken by the Selection Committee dated 17<sup>th</sup> July, 2024, it is hereby notified that **4 (Four)** posts out of the total 119 (One Hundred and Nine) notified posts are to be reserved for Persons with Disabilities (PWD), which are to be filled up by way of Direct Recruitment from eligible and willing candidates with benchmark disabilities. The recruitment will be in continuation of and as part of the ongoing Group – D Posts' Recruitment Examination, 2023.
