1. The Daily Wagers (Sanitation Attendant, Lawn Attendant, Farash, Mali, and Sweeper) working under their respective Courts shall be informed to fill up the one-page online form through the link provided below:

2. The complete list of 109 (one hundred nine) *Daily Wagers (Sanitation Attendant, Lawn Attendant, Farash, Mali, and Sweeper)* deployed in the respective Courts is enclosed at **ANNEXURE-I**. The names of all Daily Wagers are as per their **Aadhaar Card records**.
3. The newly engaged Daily Wagers shall report to the Court Officer-I in the case of the High Court and to the concerned District & Sessions Judges in the case of the District Courts, for further directions and deployment.
