


No. HCM/P-65/2019-Estt(I)/1999⁵: For the benefit of all concerned, the existing methodology for awarding marks for Computer Typing Test for all Departmental Promotions/Recruitment Examinations in the High Court and District Courts is hereby explained as under:

"Candidate(s) with the highest net typing speed in the examination will be awarded full mark and all other candidates will be awarded marks by multiplying their net typing speed with a factor (i.e. Full Mark ÷ Highest Net Typing Speed)"

Illustrations for awarding marks for computer typing test where full marks of the test is **25 marks** and the highest net typing speed is **50 wpm** is given below:

1. Net Typing Speed: **50 wpm**, **25 marks** will be awarded.
2. Net Typing Speed: **42 wpm**, **21 marks** [42*(25/50)] will be awarded.
3. Net Typing Speed: **35 wpm**, **17.5 marks** [35*(25/50)] will be awarded.

This methodology will continue to apply in all future similar examinations.
