Imphal, the 5th July, 2024

No. HCM/1/96-BENCH: In view of the order dated Imphal, the 4th July, 2024 issued by the State Government declaring 5th July 2024 as a public holiday for all Government Offices including Public Sector Undertakings/Corporations/Autonomous Bodies/Societies under the Government of Manipur, under the powers conferred by explanation to Section 25 of the Negotiable Instruments Act, 1881, and in consideration of the inundation of several places in the districts of Imphal West, Imphal East, Kangpokpi, Senapati, Thoubal and Bishnupur caused by the overflow of rivers due to incessant rains, it has become necessary to take precautionary measures to ensure the safety and well-being of all stakeholders including Hon'ble Judges, lawyers, litigants, staff, and all concerned, and further taking into consideration that 5th July, 2024 is the last working day of the High Court before the ensuing summer vacations; it is accordingly notified as under:

- i) Only urgent motion/admission matters before regular division bench/special division bench and motion items before single benches in the cause list dated 5th July, 2024 of the High Court of Manipur will be taken up; while rest of the items will be re-scheduled on appropriate dates, and until then, interim orders, if any subsisting in them shall remain in force.


