No. HCM/PRO(SC)/2017-Estt.II/ It is hereby informed to all concerned that the Selection Committee has initiated the process for filling up 24 (twenty four) vacant posts of LDA by Promotion in the District Courts

Sl. No. 15 Note (ii) of Schedule C of Manipur District Courts Service Rules, 2014, provides "For being promoted from Peon, Sweeper, Mali, Chowkidar, Duftry, Process Server and Bailiff to the post of LDA, the candidates shall pass a Computer Typing Test with a minimum speed of 20 words per minute. The scheme of examination shall consist of (a) Computer Typing Test (b) Examination of Service Records."

The Computer Typing Test is scheduled to be held on **18th of December, 2023**. The list of 43 (Forty three) eligible employees who are shortlisted for the Typing Test is enclosed as Annexure – I. Annexure – II is the list of 36 (Thirty six) employees who are ineligible on account of lack of requisite educational qualification.

Any employee who claims to be eligible but not included in the Annexure – I may submit representation for inclusion of his/ her name to the Registry either by hard copy or via email - establishment.ii.hcm@gmail.com or whatsapp No. 9774468938 on or before 15th of December, 2023.

The Venue of the Computer Typing Test shall be notified later after consultation with the concerned District Judges/controlling Officers.
