1.	State Information Commissioner	1 (one)

2. A. Eligibility condition:

As provided under Section 15(5) and 15(6) of the Right to Information Act, 2025 as detailed below:

- (i) The State Information Commissioner shall be persons of eminence in the public life with wide knowledge and experience in law, science and technology, social service, management, journalism, mass media or administration and governance.
- (ii) The State Information Commissioner shall not be a Member of Parliament or Member of the Legislature of any State or Union Territory, as the case may be, or hold any other Office of profit or connected with any political party or carrying on any business or pursuing any profession

B. Other essential qualification:

- (i) The person should be a Citizen of India.
- (ii) The person should not be of unsound mind, insolvent or convicted for any crime.

3. **Age:** Person who have attained the age of 65 years shall not be eligible for appointment.

4. **Terms of Office:** Under section 16 (2) of the RTI Act, 2005 read with Section 12 of the Right to Information Rules, 2019 (notified vide Ministry of Personnel, Public Grievances & Pensions, Deptt. Of Personnel & Training No. G.S.R. 810 (E) dated 24<sup>th</sup> October, 2019):-

Every State Information Commissioner shall hold office for a term of three years from the date on which he enters upon his office or till he attains the age of sixty-five years, whichever is earlier, and shall not be eligible for reappointment as such State Information Commissioner:

Provided that every State Information Commissioner shall, on vacating his office under this sub-section, be eligible for appointment as the State Chief Information Commissioner in the manner specified in sub-section (3) of section 15.

Provided further that where the State Information Commissioner is appointed as the State Chief Information Commissioner, his term of office shall not be more than five years in aggregate as the State Information Commissioner and the State Chief Information Commissioner.

5. General conditions for Recruitment:


- (i) Candidates must fulfil the qualification and experience on the date of application. Education qualification must have been obtained from recognised University/Institute/Board/College only.
- (ii) Selection/appointment will be subject to fulfilment of eligibility conditions, experiences etc., as also to verification of testimonials, antecedents and past service.

6. The salary, allowances and other terms and conditions of service of the State Information Commissioner shall be as per the Right to Information Act, 2005 read with Right to Information (Term of office, Salaries, Allowances and Other Terms and Conditions of Service of State Information Commissioner in the State Information Commission) Rules, 2019.

7.
