Ms. Nemkholam Lhungdim shall, in addition to her normal duties, look after the Court of JMFC/Civil Judge (Jr. Divn.), Pherzawl till Mr. Mangvung Tongminthang Haokip, who is undergoing training, is released by the Manipur Judicial Academy.
